राजस्थान की दो लोकसभा और एक विधानसभा सीट के उपचुनाव में जीत के लिए भाजपा ने रणनीति बनानी शुरू कर दी है। मुख्यमंत्री वसुंधरा राजे ने शनिवार को अलवर के मुंडावर विधानसभा सीट का सघन दौरा कर उपचुनाव जीतने का मंत्र कार्यकर्ताओं को दिया। भाजपा ने इन दोनों क्षेत्रों के पार्टी पदाधिकारियों को चुनाव जीतने के फार्मूले पर काम करने का निर्देश दिया है।

प्रदेश भाजपा अध्यक्ष अशोक परनामी की अध्यक्षता में अजमेर और मांडलगड इलाके के

भाजपा नेताओं की यहां हुई बैठक में उपचुनाव को लेकर विचार-विमर्श किया गया। परनामी का कहना है कि प्रत्याशी का चयन रायशुमारी कर किया जाएगा। पार्टी के केंद्र और राज्य स्तर पर सर्वे के आधार पर प्रत्याशी तय किए जाएंगे। इसमें पार्टी के कार्यकर्ताओं की राय ली जाएगी। अजमेर लोकसभा सीट के सभी आठों विधानसभा क्षेत्रों के भाजपा पदाधिकारियों ने उपचुनाव को लेकर अपनी राय पार्टी नेतृत्व को दी। परनामी का दावा है कि भाजपा दोनों लोकसभा और मांडलगड विधानसभा सीट का उपचुनाव कार्यकर्ताओं की मेहनत से जीतेगी।

तमिलनाडु में भारी बारिश का कहर

चेन्नई, 4 नवंबर (भाषा)।

तमिलनाडु के अन्य क्षेत्रों के अलावा इस महानगर और निकटवर्ती कर्नापूरम, तिरुवल्लूर जिले में बारिश अब भी जारी है। मौसम विज्ञान विभाग ने बंगाल की खाड़ी में कम दबाव के कहर बने होने के कारण अभी बारिश जारी रहे का पूर्वानुमान लगाया है। चेन्नई में एक अक्तूबर से चार नवंबर के बीच होने वाली सामान्य बारिश की तुलना में 93 फीसदी अधिक बारिश हुई है।

मौसम विज्ञान विभाग ने कहा कि पश्चिम बंगाल की खाड़ी में कम दबाव का क्षेत्र और ऊपरी चक्रवात परिसंचरण के कारण अभी और बारिश होने की संभावना है। राज्य के कुछ इलाकों में हल्की से मध्यम बारिश दर्ज की गई। बस और रेल सेवाओं में देरी और गंभीर जाम के कारण यात्रियों को लगातार परेशानी हो रही है। बारिश के कुछ इलाकों में हल्की बारिश, अन्य में मध्यम और कुछ में भारी बारिश हो रही है।

राज्य में 27 अक्तूबर को उत्तर-पूर्व मानसून शुरू होने के बाद से वर्षाजनित घटनाओं में अभी तक आठ लोगों की मौत हो चुकी है। एरिया साइक्लोन वार्निंग सेंटर के निदेशक एस. बालाचंद्रन ने कहा कि एक अक्तूबर से चार

सहारनपुर, 4 नवंबर (भाषा)।

उत्तर प्रदेश के सहारनपुर जिले में थाना नकुड़ के अंतर्गत ग्राम नल्हेडा मे कर्ज में डूबे एक किसान ने आत्महत्या कर ली। एस पी (देहात) विधा सागर मिश्रा ने शनिवार बताया कि किसान प्रवीण कुमार ने शनिवार दोपहर को आत्महत्या कर ली।

नक्सलियों और बीमारियों से लड़ रहे जवानों की स्वास्थ्य सुविधाएं बढ़ीं

रायपुर, 4 नवंबर (भाषा)।

छत्तीसगढ़ के नक्सल प्रभावित इलाकों में पुलिस को नक्सलियों के साथ दृष्टित पानी और मच्छरों के कारण होने वाली बीमारियों से भी लड़ना पड़ रहा है। पुलिस जवानों की इस परेशानी के मद्देनजर अब बीजापुर जिले के थानों में आरओ सिस्टम और फॉगिंग मशीनों की व्यवस्था की जा रही है।

बीजापुर जिले के पुलिस अधीक्षक मोहित गर्ग ने शनिवार दूरभाष पर बताया कि जिले के धुर नक्सल प्रभावित इलाकों में तैनात पुलिस जवानों को अक्सर दृष्टित पानी और गंदगी से होने वाली बीमारियों का सामना करना पड़ता है। जवानों की इस स्थिति को देखते हुए जिले के सभी पुलिस थानों और शिविरों में साफ पानी के लिए आरओ मशीन और 16 स्थानों पर धुएं वाली मशीनों की व्यवस्था की गई है।

गर्ग ने बताया कि जिले में तैनात पुलिस जवानों के लिए रोजमर्रा की जरूरतों और पेयजल की व्यवस्था की गई है। उन्हें पीने के पानी को साफ करने लिए स्थानीय और पारंपरिक तरीकों पर निर्भर रहना होता था। यह स्थिति उस समय और भी खराब हो जाती थी जब जवान नक्सलरोधी अभियान के लिए निकलते थे। ऐसे में पुलिस के जवान नदी-नाले का पानी पी लेते थे और बीमार पड़ते थे। इसे देखते हुए पुलिस प्रशासन ने थानों और शिविरों में आरओ प्रणाली लगाने का फैसला किया है। पुलिस अधिकारी ने बताया कुछ समय पहले ही जिले के सभी 21 थानों और छत्तीसगढ़ सशस्त्र बल के 24 शिविरों में आरओ सिस्टम लगाने का काम पूरा हो गया है। बीजापुर जिला बस्तर क्षेत्र का एकमात्र जिला है, जहां के सभी थानों में साफ पानी के लिए आरओ सिस्टम लगाया गया है। ये सुविधाएं अभी तक केंद्रीय बलों के शिविरों में ही उपलब्ध थीं।

नवंबर के बीच तमिलनाडु में 19 सेंटीमीटर

बारिश हुई, जबकि सामान्य तौर पर 21 सेंटीमीटर बारिश होती है। उन्होंने कहा कि चेन्नई में इस दौरान 62 सेंटीमीटर बारिश हुई है जबकि सामान्य तौर पर 32 सेंटीमीटर बारिश होती है। तटीय इलाकों में दो-तीन दिनों में बारिश में कमी आ सकती है। पिछले 24 घंटे में तमिलनाडु और पुडुचेरी के तटीय इलाकों में काफी बारिश हुई है। स्कूल और कॉलेज, जो 31 अक्तूबर से यहां बंद है, वह आज भी बंद रहे और कई विश्वविद्यालयों में परीक्षाएं भी स्थगित कर दी गई हैं। राज्य स्तर की 'राष्ट्रीय मेधा खोज परीक्षा' जो शनिवार होनी थी, वह अब 18 नवंबर को होगी। निगम के अधिकारी, जिला कलेक्टर (कांचीपुरम, तिरुवल्लूर) सहित अन्य अधिकारी मिलकर राहत कार्य में जुटे हैं।

उत्तरी चेन्नई के एमकेवी नगर के कुछ हिस्सों, दक्षिण चेन्नई के मरिपक्कम इलाके और पश्चिम चेन्नई के कत्तापक्कम के पास पोखर जैसे बाढ़ ग्रस्त इलाकों में सुरक्षा कारणों से बिजली काट दी गई थी। सोशल मीडिया पर लोगों ने बाढ़ग्रस्त इलाकों और यातायात परिवर्तन के बारे में लिखा और लोगों ने नर्मगालम एवं पल्लिकराने में बाढ़ प्रभावित इलाकों में खाने के पैकेट और पानी बांटा।

ट्रांसफॉर्मर हादसे में एक और ने दम तोड़ा, मृतक संख्या 18 हुई

जयपुर, 4 नवंबर (भाषा)।

जयपुर के निकट शाहपुरा के खातोलाई में तीन नवंबर को बिजली का ट्रांसफॉर्मर फटने और करंट लगने की घटना में शनिवार को एक और महिला ने दम तोड़ दिया, जिससे मृतकों की संख्या बढ़ कर 18 हो गई है। महिला का उपचार सवाई मानसिंह अस्पताल में चल रहा था। शाहपुरा थाना पुलिस ने शनिवार को बताया कि अस्पताल में भती लोगों में से 65 वर्षीय एक महिला के शनिवार को दम तोड़ देने से इस घटना में मरने वाले लोगों की संख्या बढ़ कर 18 हो गई है। गौरतलब है कि एक विवाह रस्म के दौरान बिजली का ट्रांसफॉर्मर फटने की घटना में पांच लोगों की मौके पर ही मौत हो गई थी, जबकि 13 लोगों ने अस्पताल में उपचार के दौरान दम तोड़ा। मृतकों में अधिकतर महिलाएं हैं। मृतकों के आश्रितों को राज्य सरकार ने मुख्यमंत्री सहायता कोष से और बिजली निगम कंपनी ने पांच-पांच लाख रुपए की आर्थिक मदद देने की घोषणा पहले ही कर दी थी।
