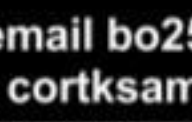

अक्टूबर में निर्यात 1.11 फीसद और आयात 16.31 फीसद घटा विदेशी मुद्रा भंडार 448 अरब डॉलर के नए रिकॉर्ड स्तर पर

नई दिल्ली, 16 नवंबर (भाषा)।

देश के निर्यात में लगातार तीसरे महीने गिरावट आई है। अक्टूबर में निर्यात 1.11 फीसद गिरकर 26.38 अरब डॉलर रहा। इसकी प्रमुख वजह पेट्रोलियम, कालीन, चमड़ा उत्पाद, चावल और चाय के निर्यात में कमी आना है।

अक्टूबर में देश का आयात भी घटा है। शुक्रवार को जारी सरकारी आंकड़ों के अनुसार समीक्षाधीन अवधि में यह 16.31 फीसद घटकर

37.39 अरब डॉलर रहा। आयात में गिरावट के कारण देश का व्यापार घाटा भी घटकर 11 अरब डॉलर पर आ गया है। यह पिछले साल अनुक्रम में 18 अरब डॉलर था। समीक्षावधि में सोने का आयात पाँच फीसद बढ़कर 1.84 अरब डॉलर रहा है। इस दौरान 30 प्रमुख क्षेत्रों में से 18 क्षेत्रों का निर्यात घटा है। पेट्रोलियम उत्पाद, कालीन, चमड़ा उत्पाद, चावल और चाय का निर्यात क्रम से 14.6 फीसद, 17 फीसद, 7.6 फीसद, 29.5 फीसद और 6.16 फीसद घटा।

इससे पहले देश का कुल निर्यात सिस्तंबर में 6.57 फीसद और अगस्त में 6 फीसद घिरा था देश का निर्यात अब तक नीचे ही बना हुआ है। इससे देश की पूरी आर्थिक वृद्धि दर पर बोझ बढ़ सकता है जो चालू वित्त वर्ष की पहली तिमाही में छह साल के निचले स्तर यानी पाँच फीसद तक आ गई है। सिस्तंबर में देश का औद्योगिक उत्पादन गिरकर 4.3 फीसद पर आ गया है और इसकी अहम वजह विनिर्माण, बिजली और खनन क्षेत्र का खराब प्रदर्शन है।

देश के विदेशी मुद्रा भंडार में वृद्धि जारी है। गत आठ नवंबर को समाप्त सप्ताह में यह 1.71 अरब डॉलर बढ़कर 447.81 अरब डॉलर के रिकॉर्ड स्तर पर पहुंच गया। इससे पिछले सप्ताह में विदेशी मुद्रा भंडार 3.5 अरब डॉलर

बढ़कर करीब 446.1 अरब डॉलर के स्तर पर पहुंचा था।

आंकड़ों के अनुसार विदेशी मुद्रा भंडार की वृद्धि में विदेशी मुद्रा आस्तियों की वृद्धि का मुख्य योगदान है। आलोच्य सप्ताह के दौरान विदेशी मुद्रा आस्तियां 2.17 अरब डॉलर बढ़कर करीब 415.83 अरब डॉलर पर पहुंच गईं।
