# Pinarayi, PM have 'friendly' meet

ON HIS first visit to Delhi after taking over as Kerala Chief Minister, Pinarayi Vijayan Saturday signalled a subtle shift in the state's position on Mullaperiyar dam, a contentious issue with Tamil Nadu. Vijayan met Prime Minister Narendra Modi, whom he described as "friendly", as well as President Pranab Mukheriee.

Vijayan asked for the Centre's help for the state's development during his meetings with Home Minister Rajnath Singh and Finance Minister Arun Jaitley. Modi, in turn, told Vijayan to consider the PMO his home.

What was surprising were Vijayan's comments on Mullaperiyar dam. Kerala has been demanding construction of a new dam, citing safety of the

structure that is over a century old. But on Saturday, he told reporters that Kerala should move forward on the basis of new studies, dispelling concern about the safety of the dam. At the same time, he said Tamil Nadu

should not try to raise the water level. He also said Kerala should shun the path of confrontation with Tamil Nadu.

During his meetings with Rajnath, the two discussed the issue of CPM-BIP violence.

Pandits: CM's pigeon-cat analogy draws flak



JAMMU AND Kashmir Chief Minister Mehbooba Mufti on Saturday said the PDP-BIP government is committed to getting Kashmiri Pandits and other migrants back to the Valley, and that they will be given transit accommodation until the situation is conducive for them to return to native villages.

But she stirred a controversy with an analogy made in her remarks to the Assembly. "As of now," Mehbooba said, "we can't put them like pigeons among the cats... We are very clear on that."

Criticising her for "demonising" the people of Kashmir with this "hunter and hunted" inference, the Opposition National Conference (NC) sought an apology from the Chief Minister.

"Chief Minister Mehbooba Mufti owes an apology to the people of Kashmir for demonising and defaming them through her contemptuous and highly inappropriate 'cats and pigeons' analogy while speaking on the Kashmiri Pandit rehabilitation issue in the Assembly," NC spokesman Junaid Mattu said. "She (Mufti) has (alleged that)... Kashmiris are some sort of killers and hunters, and that Kashmiri

Pandits are unsafe in their company and hence need to be isolated," said Mattu.

Talking about the return of Kashmiri Pandits to the Valley, Mehbooba told the House, "We will give them (Pandits) a composite transit accommodation. This is not a township. There would be 50 percent Kashmiri Pandits in it, and 50 per cent (people) from other religions."

Telling the Opposition that they cannot call such camps "Israeli-type settlements", Mehbooba said the situation in the Valley is such that even workers from different parties cannot return to their villages. "We have kept them (political workers) in hotels and given them security. (But) people who left 20 or 25 years ago...you want us to send them directly to their homes. This is not humane. This is not possible," she said.

## **'Parties at Centre have** treated J&K like a football'

JAMMU AND Kashmir Chief Minister Mehbooba Mufti on Wednesday said political parties at the Centre have treated the state like a "football". In her maiden speech in Assembly after taking over as CM, Mufti attacked opposition parties National Conference and Congress and defended the decision of her father and ex-CM Mufti Mohammad

Saveed to join hands with BIP. "Unfortunately, the kind of politics in the country is such that Jammu and Kashmir is taking a beating. Jammu and Kashmir has been turned into a football.

When there was Congress government, BIP opposed (its reconciliatory moves on Kashmir) and when BJP was in power, Congress opposed," she said.

Defending PDP's decision to form a coalition government with BIP, she said: "In Jammu, they (BJP) got the mandate and in Kashmir, we got it. We could have joined hands with your party or Congress. We could have gone the way you went in 1987. Then people in Kashmir took up guns."

The CM further said it was a "very difficult" decision for Sayeed. "People would have appreciated his stance of not joining hands with BJP. But he (Mufti) always put the interests of the people first," she said.

# Narayanasamy to be Puducherry CM

FORMER UNION minister V Narayanasamy will be the next Chief Minister of Puducherry. Ending the week-long suspense and hectic behind the scene negotiations, the 70-year-old AICC general secretary was on Saturday elected unanimously as the leader of the Congress legislature party.

Narayanasamy is not an MLA as he did not contest the Assembly polls. He will have to get elected as an MLA within the next six months. It is virtually a birthday gift for Narayanasamy, who will turn 70 on Monday.

There was intense lobbying in the Congress for the post of the Chief Minister. Although state Congress chief A Namachivayam and former CM V Vaithilingam were in the race, Narayanasamy bagged the top

post as majority of the MLAs backed him.

The Congress has 15 MLAs in the 30 member House. Its ally DMK had won two seats.

The announcement of Narayanasamy's election as leader of the Congress legislature party was made in Puducherry by former Delhi chief minister Sheila Dikshit and AICC general secretary Mukul Wasnik after a meeting with the newly-elected Congress MLAs.

**Cong faction protests** 

Unhappy over the election of Narayanasamy as the new Chief Minister, supporters of a faction in the Congress went on a rampage, damaging buses in Puducherry. A bus driver and several passengers were injured in the attack by protesters believed to be supporters of PCC president A Namassivayam. They contended that a person who had not contested the elections should not be made chief minister.



## कर्ज से बुंदेलखंड के किसानों का जीना

छतरपुर, 28 मई (जनसत्ता)। अच्छे दिन के बाद देश बदलने के नारों की गूंज में बुंदेलखंड का किसान गुम-सा हो गया है। बुंदेलखंड में हालात न बदलने का ही नतीजा है कि सात दिन पूर्व ही कर्ज में डुबे एक युवा किसान ने आत्महत्या कर ली और एक ने बिजली के टावर पर चढ़कर खुदकुशी की कोशिश की।

टीकमगढ जिले के मोहनगढ थाना के ग्राम खाकरौन निवासी 26 वर्षीय लक्ष्मन पाल कर्ज चुका पाने के कारण इस तरह हताश हुआ कि उसने खेत पर फांसी पर झुलकर आत्महत्या कर ली। 20 मई को हुई इस घटना में किसान का जो दर्द सामने आया वह शायद सरकारें आज तक नहीं समझ सकी है। मतक के भाई गोविंददास का कहना है कि लक्ष्मण करीब डेढ लाख रुपए के कर्ज में दबा हुआ था। पिता भागीरथ की बीमारी और पारिवारिक काम के लिए उसने यह कर्ज लिया था। उम्मीदें डेढ एकड़ फसल पर थीं।जो सुखे की भेंट चढ़ गई। साहकारों का कर्ज दिनोंदिन बढ़ता जा रहा था। इस कारण वह दिल्ली मजदूरी करने चला गया था। पिता की तबीयत बिगड़ने पर वह उसे देखने आया था। बताया जा रहा है कि दिल्ली में भी इस बार मजदूरी की मांग में कमी आई है। इस कारण लक्ष्मण वहां भी भटकता ही रहा।

परिवार का भरण पोषण, पिता की बीमारी और साहूकारों के कर्ज के दबाब में लक्ष्मण इस तरह घरा कि उसने आत्महत्या कर ली। यही हाल बुंदेलखंड के दूसरे इलाके के किसानों का है। दो हफ्ता पहले ही सागर जिले के सरखी थाना

के गांव समनापुर में पारिवारिक तंगी से आजि महेश चढार नामक व्यक्ति ने हाइटेंशन लाइन टावर पर चढ़कर आत्महत्या का प्रयास किया थ उसे किसी तरह बचा लिया गया था। महेश अनुसार, उसके पास न तो राश्चनकार्ड है और ही जॉब कार्ड। जिस झोपड़ी में रहता था उसे चा ने छीन लिया। वहीं घर में बच्चों को खिलाने लिए राशन नहीं। जब चारों बच्चों ने खाना मां तो उसके सामने आत्महत्या करने के सिवाय रास नहीं था। इससे पहले अप्रैल माह में भी बुंदेलखं के छतरपुर जिले में कर्ज से दबे दो किसानों आत्महत्या कर ली थी।8 अप्रैल को छतरपुर जि के लवकशनगर थाना के ग्राम पटना में 10 बी के मालिक 58 वर्षीय बाबलाल तिवारी ने खेत लौटकर घर में जहर खा लिया था।
