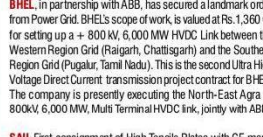
INAUGURATION (BHEL)

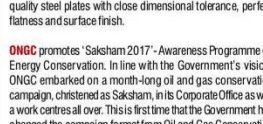
WORKSHOPS (PFMDA)

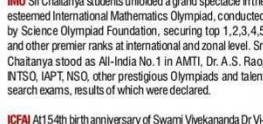

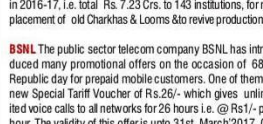
BOOK RELEASE (NBT)
