

PowerGrid seeks nod to raise up to ₹10,000 cr via bonds

STATE-OWNED TRANSMISSION

UTILITY Power Grid said on Monday it will seek shareholders' approval next month to raise up to ₹10,000 crore through the issuance of bonds on a private placement basis.

A special resolution will be considered "to raise funds up to ₹10,000 crore, from domestic market through issue of secured/unsecured, non-convertible, non-cumulative, redeemable, taxable/tax-free debentures/bonds under private placement during 2020-21 in up to twenty tranches/offer," according to a notice for the annual general meeting, scheduled for August 27.

In its July 3 meeting, the board approved raising up to ₹10,000 crore in up to 20 tranches depending upon the requirement of funds during 2020-21 to finance of the firm's capital expenditure requirement, providing inter-corporate loans to wholly-owned subsidiaries, other purposes and for general corporate purposes.
