Sub: <u>Execution of definitive documents for sale/disposal of 11 hybrid annuity road assets and 1 toll</u> road asset jointly owned by PNC Infratech Limited and PNC Infra Holdings Limited ("Sellers") to Highway Infrastructure Trust ("Buyer").

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, please be informed that the Board of Directors of the PNC Infratech Limited ("Company") in its meeting held on January 15, 2024 has approved the Company entering into a Master Securities Purchase Agreement with Highway Infrastructure Trust ("Buyer"), pursuant to which the Company together with its Wholly Owned Subsidiary namely PNC Infra Holdings Limited agreed to sell their 100% (one hundred percent) shareholding and management control in one or more tranches in following twelve special purpose vehicles("SPVs" or "Assets" or "Target SPVs") to the Buyer.
