The Company and SPVs appeared before the MoRTH on 18.10.2024 for the hearing and submitted the documents. Upon hearing the Company, SPVs and NHAI, vide its Order dated 18.10.2024 MoRTH has disqualified the Company and the two SPVs from participating in any tender process of the Ministry for a period of one year with effect from 18.10.2024. |
