Single Judge of Hon'ble High Court of Delhi and Ministry of Road Transport & Highways ("MoRTH") Disqualification Order dated 18.10.2024, before Division Bench of Hon'ble High Court of Delhi

In continuation of earlier intimations dated October 21, 2024 and October 30, 2024, regarding the Judgement pronounced in the matter of Writ Petitions and Applications seeking Staying of MoRTH Order dated 18.10.2024 before Hon'ble High Court of Delhi by the PNC Infratech Limited (Company) and 2 of its subsidiaries namely PNC Khajuraho Highways Private Limited and PNC Bundelkhand Highways Private Limited, the additional details of the matter pursuant to the SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/23 dated July 13, 2023, are mentioned as below:

Brief details of the Dispute	As intimated earlier, MoRTH vide its' Order dated 18.10.2024, has disqualified the Company and the above mentioned two SPVs from participating in tender process of the Ministry for a period of one year with effect from 18.10.2024. The Company and the two SPVs filed Writ Petitions before the Hon'ble High Court of Delhi challenging the aforesaid Order of MoRTH on 21.10.2024. The Writ Petitions have been dismissed by the Hon'ble High Court vide Order dated 29.10.2024.
		Now, the Company and the two SPVs filed Letters Patent Appeals (LPAs) challenging the Order of Ld. Single Judge, Hon'ble High Court of Delhi dated 29.10.2024 and MoRTH Disqualification Order dated 18.10.2024 before Division Bench of the Hon'ble High Court of Delhi on 27/28 November, 2024 along with Applications seeking Ad-Interim Orders.
