### Qualified Opinion expressed by the statutory auditors : (a) Material uncertainty related to Going Concern

The Investment Company has defaulted in repayment of borrowings to its financial institutions lenders and others. In view of the Management, the Investment Company would be able to improve its net working capital position to discharge its current and non-current financial obligations as described in Note No 4 & 7 to the Statement. However, in view of the uncertainties involved, these events and conditions indicate a material uncertainty which may cast a significant doubt on the Investment Company's ability to continue as a going concern. Accordingly, the use of going concern assumption of accounting in preparation of this Statement is not adequately and appropriately supported as per the requirements of Indian Accounting Standard 1. चिकित्सकों द्वारा प्रमाणित मृत्यु के मामलों की संख्या बढी

नई दिल्ली, 29 मई (भाषा)।

देश में पिछले एक दशक में मौत के कुल पंजीकृत मामलों में से चिकित्सकों द्वारा प्रमाणित मृत्यु के मामलों की संख्या 2.5 फीसद बढ़ी है, लेकिन बिहार, गुजरात, दिल्ली, कर्नाटक, मध्य प्रदेश, उत्तराखंड, त्रिपुरा और केरल जैसे राज्यों में ऐसे मामले घटे हैं। भारत के महापंजीयक कार्यालय की 'मृत्यु के कारणों की चिकित्सकीय प्रमाणीकरण रिपोर्ट-2020' से यह जानकारी मिली है। इसमें कहा गया है कि वर्ष 2011 से 2020 तक पिछले 10 वर्षों की अवधि में चिकित्सकों द्वारा प्रमाणित मौत के आंकड़ों से यह स्पष्ट होता है कि गोवा ने इस पैमाने पर लगातार अच्छा प्रदर्शन किया है और इसके बाद लक्षद्वीप का स्थान रहा है।
