2. This Form should be completed and signed by the Member (as per the specimen signature registered with the Company/Depository Participants). In case of joint holding, this Form should be completed and signed by the first named Member and in his absence, by the next named Member.
3. The votes should be cast either in favour or against the resolution (s) by putting the tick (✓) mark in the column provided for assent or dissent. Postal ballot form containing bearing (✓) in both the column will render the form invalid. Duly completed Postal Ballot Form should reach the Scrutinizer not later than close of working hours i.e. 5.00 p.m. on Wednesday, January 18, 2017.
