PNC Infratech Bags Chakeri - Allahabad Hybrid Annuity Highway Project of Rs. 2159.0 crore

New Delhi, September 30, 2017: PNC Infratech Limited has been declared the L1 (lowest) bidder for NHAI project of 145 km long six laning of Chakeri to Allahabad section of NH - 2 from km 483.687 to km 628.753 in the state of Uttar Pradesh under NHDP Phase-V to be executed on Hybrid Annuity Mode for a Bid Project Cost of Rs. 2159.0 crores. Six firms participated in the bidding and the price bids were opened on Friday, September 29, 2017, with PNC's bid being the lowest (L1). This is the fifth hybrid annuity project won by PNC having construction period of 2½ years and operation period of 15 years.

PNC Infratech Limited is an infrastructure construction, development and management company, with expertise in execution of major projects, including highways, bridges, flyovers, airport runways, power transmission lines, development of industrial areas etc. The company has executed/is executing projects across various states in India including Rajasthan, Punjab, Haryana, Uttar Pradesh, Uttarakhand, Delhi, Bihar, West Bengal, Assam, Madhya Pradesh, Maharashtra, Karnataka and Tamil Nadu. The Company's order book in terms of outstanding contracts pending execution is valued at over Rs. 5,000.0 crore as on 30 June 2017, excluding the above new project and other three recently awarded projects and on hybrid annuity model.
